




Stellar export performance- 20% surge in Gems and Jewellery exports in May'22.

India has been prospecting new opportunities to counterbalance the effects of Russia-Ukraine conflict on Indian gems and jewellery exports. The government has set an export target for the gems & jewellery at USD 45.7 billion for the year 2022-23, the groundwork laid by trade agreements with UAE and Australia is expected to aid in reaching this new target, as per GJEPC. Currently, there is a steady progress visible in this sector with Gem and jewellery exports, totalling to Rs 25,365.35 crore (USD 3.28 billion) in May 2022, up from Rs 21,156.1 crore (USD 2.89 billion) in May 2021.

Categories showing year-on-year growth include cut and polished diamonds, gold jewellery, coloured gemstones, and polished lab-grown diamonds. April to May'22 has seen a consistent export growth for gems and jewellery, in key markets, which include the US, accounting to \$2.58 bn, Hong Kong- \$1.38 bn, UAE-\$810.16 mn, and Belgium-\$441.37 mn.

In May'22, exports of Cut and Polished Diamonds (CPD) surged 10.04 per cent to INR. 16,156.03 cr (USD 2,089.17 mn), as compared to INR. 14,681.42 cr (USD 2,004.99 mn) in 2021. Gold jewellery exports (plain and studded jewellery) in May jumped 50.11 per cent to Rs 5,273.40 cr (USD 681.47 mn), compared to Rs 3,513.08 cr (USD 479.54 mn) in May 2021, according to the data.

Coloured gemstone exports during April-May 2022 grew by 106.91 per cent to Rs 584.45 cr (USD 75.99 mn) against Rs 282.47 cr (USD 38.20 mn) during the first two months of the previous financial year.

GST rate rationalized for cut & polished diamonds from 0.25% to 1.5%

*Facts:

- Transactions in the domestic stream, which eventually culminate into exports.
- Absence of the facility to claim refund of such input tax credit accumulated on account of input services under Section 54(3) of the Central Goods and Services Act, 2017 ("CGST Act")
- Huge Input Tax Credit (ITC) accumulation with Diamond industry as on date.

*New GST rate applicable: From 18th July, 2022

*Benefits:

- Relief with regard to ITC accumulation issue
- Release of blocked working capital
- Stimulation of Diamond industry growth

The GST Council meeting held on 28th and 29th June 2022, came up with revisions in GST rates for a series of products. GST has been rationalised from 0.25% to 1.5% (effective 18th July 2022) for cut & polished diamonds, which is expected to resolve the issue of ITC accumulation in diamond industry, on account of inverted duty, under GST Regime.

This rationalisation on cut & Polished diamonds, will provide relief with regard to the issue of ITC accumulation for the diamond sector and aid in releasing the blocked working capital while stimulating the diamond industry growth.

Accoladed with IGBC ranking of PLATINUM PRE-CERTIFIED GREEN BUILDING, SDB structure design is focused on energy efficiency and sensitive to the ecological sentiments.

IGBC ratings system for pre-certification assesses a project, at the design stage, for its predicted performance over the entire life cycle – basically right from the conception stage to complete operative mode.

This process leads to sustainable development of buildings, enabling limited consumption of natural resources, without sacrificing the overall facilitations of thermal, visual, or acoustic comfort of the occupants.


All the offices, at Surat Diamond Bourse are centrally air conditioned, using water cooled chiller system. Every office is sighting onto the exquisitely designed landscape courts, which are designed on the concept of "Panchtatva" (5 Elements of Nature; Air, Water, Fire, Earth, Sky) spanning almost 200 ft. wide and 300 ft. long. SUSTAINABILITY is one of the most important aspects apart from the astonishing aesthetics & landscaping, contemplated in designing this facility.

The factors which are considered for a IGBC pre-certification are:

- Sustainable Architecture and Design
- Site Selection and Planning
- Water Conservation
- Energy Efficiency
- Building Materials and Resources
- Indoor Environmental Quality
- Innovation and Development

Aspects which are considered in the design and execution are

- Microclimate – to maintain the temperature within the confined spaces
- Solar control – to reduce the direct heating due to sun light
- Wind analysis – to evaluate and maximize natural ventilation, orientation according to sun and wind direction
- Energy performance – for energy efficiency and WWR
